





**Sub: Integrity pact-Amendment**

Reference is made to the Board approval vide the minutes of 377<sup>th</sup> meeting held on 30<sup>th</sup> August 2014, the existing Integrity pact has been revised. Copy of the Revised IP format is enclosed at Annexure-I. The revised threshold value of IP is now Rs.5 Crs in place of Rs.20 Crs. In this regard, the following guidelines are issued for strict compliance.

- i. Integrity Pact has to be signed by all the vendors where HAL's estimated value of tender / procurement is Rs. 5 Crs. & above.
- ii. Integrity Pact has to be signed by the vendors as per revised format enclosed at Annexure-I.
- iii. The revised IP format and **revised threshold value of Rs. 5 Crs will be implemented w.e.f 1<sup>st</sup> Nov. 2014** for all the RFQs to be issued from 1<sup>st</sup> Nov. 2014 onwards.
- iv. All RFQs issued prior to 1<sup>st</sup> November 2014, will be guided by the earlier circular issued vide MMC No.: 38 dt.: 6<sup>th</sup> May 2011 (i.e. threshold value of Rs. 20 Crs & above and the earlier IP format)
- v. IP reference should be included in all order/contract / agreement / LTBA / LTRA for which tenders are issued with Integrity Pact requirement.
- vi. The procedure indicated at para 8.8.10 of Purchase Manual needs to be followed strictly w.r.t submission and acceptance of IP.
